# DECREE OF THE MINISTER OF FINANCE NUMBER 398/KMK.01/2004 CONCERNING

THE EXEMPTION FROM IMPORT DUTY ON THE IMPORT OF RAW MATERIALS/ COMPONENTS FOR MANUFACTURING TELECOMMUNICATIONS EQUIPMENT AND NETWORKS BY TELECOMMUNICATIONS MANUFACTURING INDUSTRY

### THE MINISTER OF FINANCE

## Considering:

- a. that in the framework of boosting the growth of telecommunications industry in the country, it is deemed necessary to provide the same treatment for telecommunications industry securing facilities in the framework of implementing government projects by loans;
- b. that the validity period of Decree of the Minister of Finance No. 381/KMK.01/2003 concerning exemption from import duty on the import of raw materials/components for manufacturing telecommunications equipment and networks expired on September 2, 2004;
- c. that based on the considerations as meant in points a and b, it is necessary to stipulate a decree of the Minister of Finance on exemption from import duty on the import of raw materials and components for manufacturing telecommunications equipment and networks by telecommunications manufacturing industry.

- 1. Law No. 10/1995 concerning customs affairs (State Gazette of 1995 No. 75, Additional State Gazette No. 3612);
- 2. Presidential Decree No. 228/M/2001;
- 3. Decree of the Minister of Finance No. 547/KMK.01/2003 concerning stipulation of tariffs of import duty on imported goods.

## To stipulate:

### Article 1

The import of raw materials/components for manufacturing telecommunications equipment and networks by the telecommunications manufacturing industry as meant in the attachment to this decree is exempted from import duty so that final tariff of import duty is 0% (nil percent).

### Article 2

The Director General of Customs and Excise on behalf of the Minister of Finance issues a decree of the Minister of Finance on the granting of the exemption as meant in Article 1 by referring to the lists and specifications of goods as stipulated in the attachment to this decree.

## Article 3

The Director General of Customs and Excise is instructed to implement the provision in this decree.

### Article 4

The decree is effective for 12 (twelve) months as from September 2, 2004.

For public cognizance, the decree shall be published by placing it in State Gazette of the Republic of Indonesia.
